More than 300 members of the Alternatives family came together in December to celebrate the achievements of our clients, and to recognize staff members and supportive members of the community. The Awards Dinner is the highlight of the year for many staff and clients as we recognize the important work done by the agency and its clients. Three clients were chosen by their Advisory Committee for demonstrating outstanding achievement over the past year.

Paloyna was recognized for her personal growth since receiving support. Before moving to the Franklin House Transitional Housing program with her children, she had experienced years of domestic violence. She was once vulnerable and unable to provide stability for her family. Now, with the help of Alternatives she is studying for her driver's permit, ESL and GED. She has also recently found her own apartment.

Gabriel lived in a group home for many years. Through support from Alternatives, he improved his daily living skills and was able to move into a more independent living arrangement. He is now a central part of his new home where he shares his energy and kind attitude.

Raul, who receives supported employment through Alternatives, needed an advocate with employers to express that his deafness was not a barrier. As a result of Raul's and the agency's efforts, he was recently promoted to a full-time position at work and is seen as a great asset by his employer.

The Advisory Committee awarded the prestigious Paul Manion Award to Michael Mavuro, who has been with Alternatives for 25 years. The Paul Manion Award is the highest award achievable by an Alternatives client. This award honors someone whose positive attitude and spirit have served as inspiration to others. The award also pays tribute to all clients who have made significant achievements.

Alternatives also recognizes key members of our community. Alternatives Educates About Support Coordination

In our continuing effort to educate and assist clients, Alternatives hosted several meetings where families of clients, staff and clients had an opportunity to meet one-on-one with support coordination agencies. Under the fee for service model clients must choose a support coordinator. The primary role of a support coordinator is to assist individuals with navigating services and resources and is rooted in individual choice.

Every individual receiving services from the Division of Developmental Disabilities will be required to select a support coordinator or be assigned one. Support coordinators will be assuming many of the roles and responsibilities that DDD case managers have had up until this point. Agencies that provide direct services cannot provide support coordination to the same client. Alternatives provides support coordination in Union and Morris counties; the agency does not provide support coordination in the counties where we provide direct services.


